Application Instructions

The open time and the setting time are strongly influenced by the working conditions, e.g. humidity, absorbency of the materials as well as the quantities applied and tension in the material.

Good results will be achieved under the following conditions:

- Room, material and glue temperature: 18°C 20°C
- Moisture content of the wood: 8 10%
- Relative humidity: 40 60%

Glue spread:

- for assembly gluing: 140 200 g/m²
- for surface gluing: 80 120 g/m²

Open time at 150 g/m²: 6 – 9 minutes

Press pressure for tension free work-pieces:
 0,1 - 0,5 N/mm²

Minimum pressing times:

- Block gluing of hardwoods: 12 15 minutes
- Joints in softwoods and chipboard: 8 13 minutes

Wood preparation:

In the case of hardwoods, the moisture content of the wood must be strictly within the specified range of 8 - 10%.

Cutting out the joints, joining and gluing should preferably be carried out on the same day.

Glue spread:

This product is normally applied evenly to one side using a brush or other suitable spreading appliance.
